	In my profession as an IT Procurement Manager in the financial services sector, I have built up a number of transferrable skills that could be applied to this role. 	How I plan to contribute to the future work of the board
	I have worked in the procurement and commercial field for over 13 years, in varied sectors including regulated organisations.
